## Something to Think About

In the parable of the talents, each man was given a different number of talents. Two were faithful in investing their talents, and one was not. The two who invested the talents had more to give back to the master when he returned. In the parable, talents refer to money. For us today, a talent is a gift or ability given to us by God. God gives us a variety of gifts to serve Him. It honors God when we develop the talents He has given us and use those talents for Him. For example, you may be taking music lessons now, but someday you may play an instrument or sing a song in church. You may have the ability to meet new people and to make them feel welcome in class. God may use you to greet visitors and to make them feel welcome in church.
